Families stay as the guests of local congregations in the evenings who provide shelter, food, and hospitality. Each day families return to our "Day Center", where they look for work and receive counseling, budget assistance or other services as needed. All food items, nightly sleeping spaces, and our Day Center are donated by congregations. Donated goods, services, and facilities total \$396,919.

Short-term Transitional Housing: Provides temporary shelter for families. Families stay for up to 6 months in a static site transitional living home while working towards their independence. Families in this program receive the same supportive services as those in our emergency shelter program. Donated Rent discounts total \$36,000.
